

FAITH COMMUNITY NURSES

September 2024 is National Cholesterol Education Month. Likely, you've heard the word "cholesterol" mentioned throughout your daily life, but do you understand what it is and why it's important to human health? Were you aware that, according to the Centers for Disease Control and Prevention (CDC), almost 94 million people (aged 20 and older) in the United States have cholesterol numbers that are already bordering on "high" (as in higher than 200 mg/dL)? These cholesterol numbers could already be putting people at risk for serious health complications in the future if left unchecked. Considering there's now a whole month dedicated to getting the word out, it seems likely that you're not the only one who is a little confused about why cholesterol is a big deal.

What is Cholesterol? According to The American Heart Association, cholesterol is a "waxy" entity in your blood. The human body requires cholesterol to create cells, hormones, and vitamins. While not all cholesterol is bad, it's essential to know where "bad" cholesterol comes from. The liver produces the cholesterol that the human body needs. The rest comes from the food we consume (primarily animal products such as dairy and meat). There are two kinds of cholesterol — HDL cholesterol (also known as "good cholesterol") and LDL cholesterol (also known as "bad cholesterol").

According to The National Heart and Lung Institute, the most common cause of high cholesterol is unhealthy lifestyle choices. However, uncontrollable factors such as genetics, age, sex, race, certain medical conditions, and certain medications can also have an effect on your cholesterol levels.

Unhealthy lifestyle choices that increase your risk of high cholesterol include: ♦Smoking, ♦A sedentary lifestyle, ♦Eating foods high in saturated fats, ♦Stress, and ♦Drinking too much alcohol.

The following medical conditions can increase your risk of high cholesterol: ♦Being overweight or obese, ♦Diabetes, ♦HIV infections, ♦Kidney diseases, ♦Sleep apnea, ♦Lupus, and ♦Polycystic Ovary Syndrome (PCOS).

What are the dangers of high cholesterol? If your blood contains too much LDL cholesterol and/or not enough HDL cholesterol, then over time, the cholesterol will build up in your blood vessels and arteries, increasing the risk of blocking proper blood flow. Considering that your organs need adequate blood flow to oxygenate and keep your body functioning, this can quickly become serious (or even deadly). According to the CDC, the most significant risk of high cholesterol is heart disease, heart attack, and stroke caused by these blockages. Heart disease is currently the leading cause of death in the United States.

When considering the danger of high cholesterol, you may be interested to know that there are almost no warning signs that your cholesterol is high. The CDC reports that some people may not realize they even have high cholesterol until they experience angina (chest pain caused by blockages), a heart attack, or a stroke. This is why it is so vital to take preventative measures to ensure that your cholesterol levels are within a healthy range.

How to lower cholesterol Because high cholesterol can cause serious health problems, the CDC emphasizes that you should get your cholesterol levels checked *regularly* at least every five years). Outside of the doctor's office, you can also make heart-healthy choices to reduce your risk of high cholesterol by lowering your LDL numbers.

These are steps that you can take to lower LDL cholesterol: ♦Maintain a healthy weight, ♦Get regular exercise, ♦No smoking, ♦Limit alcoholic beverages, ♦Reduce your intake of unhealthy saturated fats and trans fats, ♦Increase your intake of fiber and healthy fats (unsaturated fats), and ♦Talk to your doctor about whether cholesterol medication could benefit you.

Don't let high cholesterol sneak up on you and cause serious health issues. By knowing your risk factors, regularly getting your blood tested, and following a heart-healthy diet, you can avoid the risks of high cholesterol. Seriously consider making an appointment with your primary care physician to have your cholesterol levels checked. This way, you and your doctor can go over the best plan of attack against high cholesterol for you.

Ask The Weatherman By: Bill Mork

Was Hurricane Debby mostly windy or mostly wet? Mostly wet as Debby was a slow-moving and erratic Category I hurricane that caused widespread flooding in Southeastern U.S. The 4th named storm and second hurricane of 2024; Debby developed from a tropical wave first noted on 26 Jul. The disturbance organized into a tropical depression early on 3 Aug and became tropical storm Debby later that day in the Florida Straits. It moved northward, gradually reaching Category I hurricane status west of Tampa Bay, and made landfall near Steinhatchee FL early on 5 Aug. Debby weakened and slowed down over Southeastern U.S., causing widespread flooding from heavy rain. Debby re-emerged in the Atlantic on 7 Aug before slowly moving northward and making landfall in SC early on 8 Aug, then weakening to post-tropical on 9 Aug.

<u>How wet was Debby?</u> A band of showers and thunderstorms, moving south to north, with hourly rainfall rates of one inch per hour, developed over Manatee and Sarasota Counties 4-5 Aug. Storm totals in inches include downtown Sarasota 19.87, Parrish (unknown location) 18.86, 3.5 miles east of Lakewood Ranch 17.64, Rye Road (Bill Miller) 15.88, Fort Hamer Road (Bill Mork) 14.18, Lakewood Ranch (near our church) 13.84, and Sarasota-Bradenton Airport 11.06. The SRQ total was limited by a power outage. Sarasota had major flooding from Phillippi Creek which pushed several feet of water into subdivisions such as Laurel Meadows. Flooding from the Braden River brought over a foot of water into homes in Summerfield Bluff in Lakewood Ranch.

How is the Manatee River? The Manatee River hit a record level of 20.12 feet at Rye Bridge at 9:15 PM on 5 Aug after major water releases were made the same day. This caused flooding of residences downstream from the dam. It also created pressure on Gamble Creek with water showing up on Rye Road, Jim Davis Road, Golf Course Road, and in Twin Rivers. Damage from Debby has topped \$100 million in Sarasota and Manatee Counties. Manatee County once again released water from Lake Manatee during a 6-inch storm on Wed/21 Aug and forced the closure of Waterline Road. There were over 500 high-water rescues in Sarasota County and over 200 in Manatee County from Debby. Peak wind gust at SRQ was 63 mph on 4 Aug. Lowest pressure from Debby was 979 millibars or 28.91 inches of mercury. Local fatalities reached 10. The Climate Adaption Center in Sarasota pegs Debby as a 200-year flood event.

<u>How warm was July?</u> It was the 4th warmest July on record at the Sarasota-Bradenton Airport with an average temperature of 84.3 degrees, 1.2 degrees above normal. And it was the 10th warmest month of any month since records began in 1911. July rainfall total at the Sarasota Bradenton Airport was 7.55 inches, 102% of normal. July 2024 was the warmest July on record for the globe in NOAA's 175-year record. The July global surface temp was 2.18 degrees F above the average of 60.4 degrees F. This was the 14th consecutive month of record-high global temperatures, a new record monthly streak. On 15 July, a derecho that spawned 32 tornadoes broke the Chicago-area record for tornadoes in a day. Alaska had its wettest July on record.

<u>Did Hawaii break its drought?</u> It certainly did on the Big Island. Hurricane Hone passed south of the Big Island on 25 Aug as it moved westward. Very heavy rain fell across the Big Island with flash flooding. The greatest rainfall occurred in Hakalau with 27.50 inches, the 4th highest known total in the history of tropical storms passing through or near the islands of Hawaii.
